

Contract to Reserve or Purchase Puppy & Health Guarantee

Pick Your Puppy (Check One):

_____ Standard Goldendoodle - Golden Retriever Mother X Standard Poodle Sire, estimated mature weight - Large 55-70 lbs. (\$1,000.00)

_____ Standard Airedoodle - Airedale Terrier Mother X Standard Poodle Sire, estimated grown weight - Large 55-70 (\$1,000.00)

_____ Purebred Golden Retriever - Estimated mature weight 55-70 lbs. (\$500.00) includes AKC registration form

_____ Early Puppy Training - All puppies will begin collar and crate training at 5 weeks. This will include short periods of time in the crate to become accustomed to it as well as short periods of time on a loose leash. All puppies will be handled and socialized and accustomed to indoor and outdoor environments after five weeks. Puppy will go to buyer at age 8 weeks. (Included in purchase price)

_____ 4 Weeks Puppy Training - A 4 week course teaching sit, down, come, puppy's name, NO command, loose leash, and crate training. Puppy will be exposed to maximum stimulus to encourage brain growth and minimize future fear problems. The puppy will learn bite inhibition from wrestling with other puppies. Puppy will be exposed to cats, chickens, goats, children, running stream, etc. Puppy will go to buyer at age 12 weeks. (additional \$350.00)

_____ 8 Weeks Puppy Training - An 8 week course teaching all the same as the 4 week course plus the puppy will be taught the down command, heel, fetch, and will begin housebreaking. Puppy will go to buyer at age 16 weeks. (additional \$700.00)

_____ Airline Shipping - Shipping will be from Little Rock, AR or Springfield, MO depending where we are shipping to. The cost of transporting a puppy to it's new home will include the cost of airfare, cost to transport puppy to the airport, veterinary exam and airline health certificate, and purchase of an airline-approved shipping crate. Total costs for shipping will be \$350. Cost of shipping may go up or down as the airlines change their prices, so please contact us for a current quote. Shipping requirements set forth by the airlines as well as USDA will be strictly adhered to, including: Health certificates from licensed veterinarian for puppy being shipped; age of dog when shipping, and cages and shipping containers correct size, airflow, adequate strength for safety travel.

_____ Airport Pick-Up If we are meeting you at the airport to deliver your puppy, the cost for that delivery is \$100 and will include the airline health certificate prepared at veterinarian's 8-week exam, but buyer must provide shipping container for onboard transport of the puppy. To check the possibility of this option, you can choose either Little Rock, AR or Springfield, MO for the airport.

This Agreement is for purchase of a puppy from Linda Denmark of Doodledawgs in Yellville, Arkansas. We breed only using healthy parent dogs that are tested and/or examined as appropriate and found to be free from hip dysplasia and genetic defects and that have good temperaments and demonstrate high intelligence.

Security Deposit

Non-refundable (except for reasons below) security deposit to reserve a puppy for purchase is \$200.00. Buyer will specify which type and size puppy, and estimated litter date desired; and state male/female and color/coat preferences. If the male/female choice cannot be met in the planned litter, then buyer agrees to move their reservation to the next expected litter. Wait lists will be kept in a first-come, first-serve order for the expected litters. The \$200.00 deposit will reserve your puppy until two weeks after the puppy is born and at that time, the balance is due in full. Puppies will go to new homes no sooner than eight weeks of age. Wait lists will be kept in a first-come, first-serve order for the expected litters. Purchaser's name will be put on waiting list upon receipt of deposit. If there are not enough puppies in the litter, or if an expected litter does not arrive as anticipated, then the buyer's name will be placed on the list for the next available litter. Sellers will provide Buyers with a puppy within one year of receipt of Buyer's deposit, and if this fails to occur, the security deposit will be refunded. Purchasers agree that they are buying a puppy "sight unseen", except for photos and video clips of puppy. Buyers are welcome to visit our farm home to pick up their puppy, meet the parent dogs, etc., if desired. Please contact us if you wish to pick up your puppy at our home. Otherwise puppies will be selected according to needs, such as allergy-affected families getting the curliest-coat puppies, etc. as appropriate. Purchasers agree to be flexible and work with sellers in matching people with puppies. We will do the best we can to place you with a puppy that will give you delight for many, many years to come. The grown-dog weights given are estimates and cannot be guaranteed. Buyer acknowledges he/she is aware of the possibility that their puppy may not fall within these weight ranges when grown. Because this is a crossbreed, and is not a "standardized breed" there are no guarantees for size, weight or coat types when grown. Sellers will endeavor to make the best match possible between puppies and people, using the preferences stated in this Agreement.

Puppy purchase includes the following:

Puppy folder with complete health record (list of vaccinations, deworming and diet instructions) and copies of parent dog registration papers;

2-year, written health guarantee against genetic defects;

Microchipping information, puppy will be microchipped

Continued support from your breeder for advice

A book with information on Goldendoodles and training, which will be sent upon receipt of deposit to help you prepare for your puppy

A promise that if you are unable to keep your pet for justifiable causes, such as health reasons, military deployment, etc., we will help you to find a good home for your pet. It is expected that you will also make an effort to find a suitable home in the event this happens. Under no circumstances should your dog be surrendered to any organization that would not be in the best interests of the dog, nor is the puppy to be sold through a puppy broker or pet store. If you are unable to keep the puppy or dog, please contact us to see what can be worked out if you are unable to find a suitable home on your own.

Procedure to Secure Puppy

1a. Print this Buyers Agreement, fill out and mail with \$200.00 deposit check made out to Linda Denmark, 2999 MC 6035, Yellville, AR 72687

2b. Complete this form and attach to e-mail to lindadenmark@hughes.net and send \$206.00 payment (includes paypal fees) by www.paypal.com to lindadenmark@hughes.net

We will communicate with you about the progress and the arrival of the litter. Puppy photos and updates are sent out weekly, once the litter is born so that the families can watch the puppies grow.

Health Guarantee

Doodledawgs guarantees your puppy to be free from infectious diseases for 5 days after puppy leaves our premises, and guarantees puppies to be free from hip dysplasia, elbow dysplasia, cataracts, vWd, and heart problems for up to two years of age. Puppy will leave our facility clean, in good general health, and with no known physical defects. Dewormings and immunizations set forth by our veterinarian will have been completed as shown. While it is generally recognized that intestinal parasites and ear mites are common in puppies, and part of a puppy's early development, we will make every effort to prevent such parasites. Often, the stress of change and travel can cause intestinal parasites to emerge after the puppy has left its mother. Buyer agrees to continue parasite treatment (if necessary) with their veterinarian (see below). De-worming will have been done at age 2, 4, 6, and 8 weeks of age (pyrantel pamoate, Panacur and Albon) and the puppy's vaccinations will be administered at 6 and 9 and 12 weeks of age. If buyer receives puppy before vaccination schedule is complete, buyer agrees to continue with the scheduled vaccinations to assure the health of the puppy.

New owners must take their puppy to their veterinarian within 3 days of receiving pup for examination, testing for worms, treatment for worms if necessary, and to schedule ongoing immunizations. Failure to have the puppy examined by vet within 3 days of date puppy was received by buyer, or if purchaser fails to provide required immunizations or dewormings, this part of the health guarantee will be void. If the purchaser's veterinarian finds the puppy to be in poor health, the veterinarian's written description of the problems must be provided, dated within 3 days of the date purchaser received their puppy. With documentation by vet that is dated within 3 days of receipt of puppy that shows infections, seller will pay for ongoing administration of treatments not to exceed the purchase price of the puppy. Cost of exams and tests are

responsibility of buyer.

Genetic defects as specified are covered by this guarantee for two years. If the genetic defect involves suspected hip or elbow dysplasia, this must be verified by the buyer having OFA evaluation done on the x-rays. The puppy will be microchipped and microchip information must be noted by veterinarian in the report. Buyer has the option to keep the original dog and in the case of a verified genetic defect, seller agrees to cover veterinary expenses only for the treatment of the defect up to but not exceeding the purchase price of the puppy. Buyer will also have the option in the case of a verified genetic defect as covered by this guarantee, to take a replacement puppy instead of covered veterinary expenses. Cost of shipping for a replacement puppy will be the responsibility of the buyer.

To keep this guarantee in effect, buyer agrees to keep growing puppy at a healthy weight appropriate for its size; to prevent harmful exercise that strains or negatively impacts joints; and to feed their puppy a nutritious and quality brand of dog food that is specifically formulated for the particular type of dog, specifically, for dogs that will be over 50 pounds at maturity, a Large Breed Puppy Food fed according to directions on the bag.

TEMPERAMENT: Seller has chosen dogs for breeding that show desired temperaments, gentle, friendly, mellow, sociable temperaments along with high intelligence. However, temperament also depends on handling and training from puppyhood onward, therefore seller does not guarantee for temperament. It is recommended that if you wish to assure the best start for your puppy, especially if you have a working household, that you sign up for our early training for the puppy which will require that the puppy be kept here until age 12 weeks or 16 weeks depending which training you choose.

Sellers and Purchasers agree to abide by the terms of this Agreement. Health guarantee is made part of the signed document.
