

Doodledawgs Contract to Reserve or Purchase Puppy

This contract is for the purchase of an F1B Standard Goldendoodle for \$2000

Check what applies:

_____ I wish to pick up my puppy at age 8 weeks without additional training.

I want _____ Weeks Additional Puppy Training - A 2 to 6 week course teaching sit, down, come, puppy's name, NO command, loose leash, and crate training. Puppy will be exposed to maximum stimulus to encourage brain growth and minimize future fear problems. The puppy will learn bite inhibition from wrestling with other puppies. Puppy will be exposed to cats, adult dogs, children, etc. Puppy will go to buyer at completion of training. Training is an additional \$250.00 per week, with a minimum of two weeks. If purchasing the additional training, an additional \$50 per number of weeks desired will need to be added to the deposit, with the remaining amount due before shipment or at pickup.

Send this Buyer's Agreement and security deposit for \$500. The deposit can be made with Paypal using the email address lindadenmark0@gmail.com Please add 3% to cover Paypal fees or use the "friends and family" option and not have to pay the extra fees. If you get a puppy from me you are considered as friends and family.

Shipping or Picking Up? _____

This Agreement is for purchase of a puppy from Linda Denmark in Cotter, Arkansas. Security Deposit Non-refundable (except for reasons below) to reserve a puppy for purchase is \$500.00. The deposit will reserve your puppy until one week before puppy is to be shipped, at which time the balance will be due in full. If puppy is to be picked up the remaining balance can be paid at time of pick-up. Puppies will go to new homes at eight weeks of age.

Security deposit will be fully refunded if you have a medical or financial crisis caused by the pandemic or if it becomes impossible for you to travel to get your puppy due to travel restrictions caused by the pandemic. Your deposit will also be refunded if there is any problem preventing me from having a healthy, sound puppy ready for you to pick up as per agreement. If you have a deposit on a puppy you can opt to change the reservation to a future litter if circumstances prevent getting a pup from the litter you reserved from.

Buyer agrees that they are buying a puppy "sight unseen", except for photos and video clips of puppy. If you are able to come see the puppies, a viewing appointment can be scheduled. At this time, because of the pandemic, all puppies will need to be picked up. Buyer also agrees to wear a mask as required by the State of Arkansas when picking up their puppy or if wanting to see the puppies and parent dogs before deciding. Masks and social distancing will be required in all circumstances.

Puppy purchase includes the following:

Complete health record (list of vaccinations, deworming, etc)

Microchipping information and form; puppy will be microchipped

3 weeks of puppy kindergarten from ages 5 to 8 weeks

A packet of information to get you started with your new puppy

A training book

A goldendoodle pedigree of your pup's lineage

Buyer understands that the puppy is being sold for a companion animal only and agrees to have the puppy spayed or neutered by an age deemed appropriate by the buyer's veterinarian not to exceed eight months of age.

Buyer has been informed that dewclaws will not be removed and tails will not be docked.

Buyer understands that dogs cannot be returned for a refund. The procedure, should you not be able to keep your dog, is that you first make every effort to find a suitable new home for the dog on your own. Seller agrees to assist buyer in finding a companion home for the puppy in the event buyer is unable to keep the dog and has not been able to find a suitable home. Should the buyer desire to return an animal, it must be done at the buyer's expense and no refund will be given at the time of return. In such a case, seller would attempt to find a home for the puppy and money recovered would be paid to the buyer after advertising and any other incurred expenses including training and boarding are subtracted.

Health Guarantee

We guarantee your puppy to be free from infectious diseases for 5 days after puppy leaves our premises, and guarantee puppies to be free from hip dysplasia, elbow dysplasia, cataracts, vWd, and heart problems for up to two years of age. Puppy will leave our facility clean, in good general health, and with no known physical defects. Dewormings and immunizations set forth by our veterinarian will have been completed as shown. While it is generally recognized that intestinal parasites and ear mites are common in puppies, and part of a puppy's early development, we will make every effort to prevent such parasites. Often, the stress of change and travel can cause intestinal parasites to emerge after the puppy has left its mother. Buyer agrees to continue parasite treatment (if necessary) with their veterinarian (see below). De-worming will have been done at age 2, 3, 4, 6, and 8 weeks of age (pyrantel pamoate, Safeguard and Albon as needed) and the puppy's vaccinations will be administered at 7, 9 and 12 weeks of age. If buyer receives puppy before vaccination schedule is complete, buyer agrees to continue with the scheduled vaccinations to assure the health of the puppy.

New owners must take their puppy to their veterinarian within 3 days of receiving pup for examination, testing for worms, treatment for worms if necessary, and to schedule ongoing immunizations. Failure to have the puppy examined by vet within 3 days of date puppy was received by buyer, or if purchaser fails to provide required immunizations or dewormings, this part of the health guarantee will be void. If the purchaser's veterinarian finds the puppy to be in poor health, the veterinarian's written description of the problems must be provided, dated within 3 days of the date purchaser received their puppy. With documentation by vet that is dated within 3 days of receipt of puppy that shows infections, seller will pay for treatment. Cost of exams and tests are responsibility of buyer.

Genetic defects as specified are covered by this guarantee for two years. All genetic diseases the parent dogs have been tested for will be covered for the lifetime of the dog. The puppy will be microchipped and microchip information must be noted by veterinarian in the report for any claim on this guarantee. If the genetic defect involves suspected hip or elbow dysplasia, this must be verified by the buyer having OFA evaluation done on the x-rays. Buyer has the option to keep the original dog and in the case of a verified genetic defect, seller agrees to cover veterinary expenses only for the treatment of the defect up to but not exceeding the purchase price of the puppy. Seller reserves the right to have a separate veterinarian evaluation done at seller's expense to verify the problem.

This puppy is being sold as a companion animal only and is not to be used as a breeding animal. You agree to have this pet spayed or neutered by the age of eight months. Failure to do so will void this guarantee.

To keep this guarantee in effect, buyer agrees to keep growing puppy at a healthy weight appropriate for its size, to prevent harmful exercise that strains or negatively impacts joints, and to feed their puppy a nutritious and quality brand of dog food that is specifically formulated for the particular type of dog.

Sellers and Purchasers agree to abide by the terms of this Agreement.
